Resolution #2018-01 Construction Evaluation Resolution

WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a "construction evaluation resolution" relating to the construction of a confinement feeding operation structure; and

WHERAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2018 and January 31, 2019 and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF EMMET COUNTY that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

Kathy Preston, Emmet County Public Health Nurse, met with the Board to discuss new phones for her office. Their office is on call 24-7 and their I-phones were having trouble responding to a call. Midwest Technology has put on a temporary patch that is working at the time. She asked the Board how does she move forward with getting new phones for her office. It was determined by the Board to have the phones for her office come out of the IT Budget, the same as the new phones for courthouse in 2017. Schumacher stated that we need to get her new phones as quickly as possible. It was the Board's determination to get an estimate and pay for the phones from the IT Budget.

Quastad discussed with the Board joint drainage assessments, for joint ditches that Emmet County does not control. He stated that
when an assessment has been called for from the control counties and Emmet County assesses their landowners that upon landowners
paying their assessment owing, that these joint drainage balances should be checked monthly and the money forwarded to the
appropriate counties.
