Juhl, Chair, called the meeting to order. Motion was made by Quastad, seconded by Hash, to approve the minutes from last week's meeting, also approving them for publication. All ayes, motion carried.

Walter Davis-Oeth, Emmet County Engineer called into the Board meeting from Palo Alto County.
