Chairman Pluth, called the meeting to order. All in attendance recited the Pledge of Allegiance. Motion by Hash, second by Glasnapp, to approve the minutes from last week's meeting, also approving them for publication. All ayes, motion carried.

During public forum, Quastad mentioned that Central Iowa Detention will be adding onto their facility due to the fact that Juvenile offenders will not be able to be held in jails in December 2020.

Glasnapp shared that NW IA Housing has approved the merger with Siouxland.

Schumacher shared that he had talked with Palo Alto Supervisor Craig Merrill regarding the Mental Health Region and what could happen when Worth, Kossuth and Hancock leave CSS. At that point Emmet would not be contiguous to CSS. Emmet plans to stay with CSS.

At 9:15 a.m., Walter Davis-Oeth, Emmet County Engineer, came before the Board, and requested a closed session pursuant to Iowa Code Chapter 21.5(1)(c) to discuss pending litigation. Motion by Schumacher, second by Quastad, to move the meeting into closed session, pursuant to Iowa Code Chapter 21.5(1)(c). Roll call vote was taken: Ayes: Schumacher, Hash, Quastad, Glasnapp, and Pluth. Nays: None. All ayes, motion carried. Meeting moved into closed session.

At 9:49 a.m., Motion by Quastad, second by Hash, to move the meeting out of closed session. All ayes, motion carried. Meeting moved out of closed session.
