At 9:30 a.m., Chair Pluth opened the public hearing for the FYE2021 Emmet County Maximum Property Tax Levy. Present were Auditor, Amy M. Sathoff, Emmet County Board members, Pluth, Quastad, Schumacher, Hash and Glasnapp. Members of the media and public present were Mike Tidemann, Ed Funston and Mary Gray. There were no written comments received. Auditor Sathoff presented the Resolution 2020-07 and explained the reason for this public hearing was due to new legislation. This sets the max levy that Emmet County can levy. The actual levy amounts will be set at the next public hearing. Motion by Quastad, second by Glasnapp to close the public hearing at 9:39 am. NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Emmet County that the maximum property tax dollars for General County Services and Rural County Services for FYE 2021 shall not exceed the following:

General County Services - \$3,671.468 Rural County Services - \$1,321,532

The Maximum Property Tax dollars requested in either General County Services or Rural County Services for FYE 2021 does represent an increase greater than 102% from the Maximum Property Tax dollars requested for FYE 2020.
