Mental Health Advocate, JoAnn Reed came before the Board with her annual report required by Iowa Code. Reed explained the referral process she goes through for committals. Typically, she meets directly with the client, however, with COVID 19 more has been done by phone. Reed shared that she does work closely with the Judge and reported that eight cases were closed last year. The Board and Reed discussed the status of County Social Services. Emmet is waiting to hear if the Governor signs the bill or does a line item veto. Schumacher is drafting a letter to the Governor asking her to review the legislation.

Reed shared with the Board of Supervisors that Judge Forsythe truly cares for Emmet County residents and that she has heard that Emmet County Law Enforcement is very good to work with. Reed is setting herself a quality assurance goal and will be sending out a survey to clients regarding her services.
